(Updated October 1, 2023)

Nineteen miles east of Skowhegan on Sebasticook River. Sebasticook & Moosehead Rail Road (until June 15, 1911 then purchased by Maine Central Railroad). Settled about 1802. Organized as a Plantation on [October 11, 1819](#). Incorporated as 235th Town on [February 7, 1820](#).
