Dr. Paul R. Briggs medical administrator

HARTLAND — Dr. Paul Revere Briggs, M.D., died Saturday at a Skowhegan Hospital following a long illness. He was born in Ashland, Mass., July 12, 1904.

He graduated from Medford (Mass.) High School and Colby Academy, New London, N.H. He received a master of science degree from Tufts University, followed by his graduation from that university's medical school, where he earned his doctor of medicine degree. He did post-graduate work at the following hospitals: Bridgeport, Conn.; Boston City, Massachusetts General and Beth Israel, Boston, Mass.; St. Vincent's, Florida; Wesson Memorial, Springfield, Mass.; New York Polyclinic; Cook County, Illinois; Presbyterian and Mt. Sinai in New York and Veterans Hospital.

He was a qualified Fellow and vice-regent of the International College of Surgeons and a diplomat of the International Board of Surgery, U.S. section. Dr. Briggs wrote many medical and scientific articles for publication, and was a member of the American Medical Writers Association.

In addition to his 35 years as medical administrator of Scott-Webb Memorial Hospital in Hartland, he found time to write a newspaper column, teach, visit many colleges, and serve as Medical Director of Industries in his adopted state of Maine.

Dr. Briggs was a Fellow of the American College of Angiology; the American Medical Authors, Inc.; and the American Society of Abdominal Surgeons.

He was a member of the American Academy for the Advancement of Science, the New England Academy of Science, the American Medical Association, the Maine Medical Association and the Somerset County Medical Association.

He served as medical advisor to the Somerset County Selective Service, and was involved in Radioactive Testing for Civilian Defense. He is listed in "Leaders of Medical Science."

Dr. Briggs did research in cancer, relating to plastics, under a grant from the American Medical Assocation and with the help of the Department of the Interior and various commercial organizations.

He was a member of the Corinthian Lodge No. 95, Ancient Free and Accepted Masons, past member of the Hartland-St. Albans Lions Club, and a member of St. Martin's Episcopal Church, Palmyra.


He was offered many positions out of state, including medical school professorships, but he felt that he owed the community his loyalty and refused all propsals. His devotion to the hospital he built up from a one-bed unit in 1935 to a 60-bed facility at the time of his death, is only one example of his love for a community he came to call home.

He is survived by his wife, Ida of Hartland; four children, Mrs. J. Edward (Beverly) Hardaire, Mrs. Kenneth (Dorcas) Miller, Mrs. John (Jennifer) Hargreaves and the Rev. Paul R. Briggs II; two stepdaughters, Mrs. John (Candy) Cooper and Cynthia B. (Sherry) Herbst; two sisters, Marion Gill of Hartford, Conn. and Katherine Briggs of Hartland; 10 grandchildren; several nieces and nephews.

Two sisters and three brothers predeceased him.

Funeral services will be held at 3 p.m. Tuesday at St. Martin's Church, Palmyra. At the family's request, there will be no public visiting hours. Arrangements are by the Crosby Funeral Home, Newport.
