William Henry Moore Civil War 1st Maine Cavalry, Co. H s/o Samuel Moore & Zipporah Evans (St Albans Village Cemetery) b. 5 Nov 1836 St Albans d. 28 Dec 1921 Hartland (St Albans Village Cemetery) at 85yrs m1. 25 Aug 1866 St Albans Eliza E. Merrill *d/o James Levi Merrill & Paulina Weston (Lyford Cemetery, St Albans)* b. May 1840 St Albans d. 18 Aug 1886 St Albans (St Albans Village Cemetery w/William) at 46yrs William & Eliza were living in St Albans in C/1870 & C/1880 with their children. Following Eliza's death, William remarried and remained in St Albans with his 2nd wife Ellen in C/1900 before moving to Newport by C/1910 where he was an officer at the Camp Benson GAR Reunion Compound. He attended the 50th Anniversary Battle of Gettysburg Reunion in 1913 where he had served during the famous battle. They were still living at Camp Benson in C/1920. William was staying at his son Birney's home in Hartland at the time of his death in 1921(See Obituary below). Eliza's paternal Great Aunt Mary "Polly" (Sawyer) Merrill married Daniel Snow. (See Snow & Mark Perkins Family)

wife Ida died, Robie was living with his sister Anne Moore in Washington D.C. in C/1940 noted
as widowed (twice) & a contractor before he married for a 3rd time to Gertrude. They remained
living at Anne's house in a basement apartment.

She was noted as a School Teacher in C/1900 living in Pittsfield before living with her father and step mother in Newport in C/1920 working as a Stenographer. She was living in Boston at the time of her father's death in 1922 noted as Miss Achsa V. Moore before moving to Washington, D. C. by 1930 where she began using Anne Weston Moore as her name incorporating her maternal grandmother Paulina Weston's surname as her middle name. Her brother Robie Moore and nephew James H. Moore were living with her in in Washington, D. C. in C/1940 where she worked as an Accountant for the Veterans Bureau reporting her name as Anne W. Moore, single and 60yrs old. She is interred as Anne Weston Moore.

Smith & Margaret Guy Brown (PG), both born in Scotland b. 3 Apr 1890 Hartland d. 29 Jan 1963 Hartland (PG w/Birney) at 72yrs Birney was living with his father & step-mother in St Albans in C/1900. He moved to Hartland soon after living with his sister Mary on Academy Street in C/1910 in the household of the widowed Mrs. Mae Bowman and her 3 young daughters (See Augustus Bowman Family) where they were both worked for a shirt manufacturing shop; likely the Fuller-Osborne Manufacturing Company. Birney soon went to work as an Electrician for the new Hartland Light & Power Company created by Dr. Charles Moulton in 1910 before he sold the business to Central Maine Power in 1920. Birney's job included operating one of the first Model T's in Hartland. Birney was working for CMP in C/1920 while they were living on Academy Street before they moved to Pleasant Street around 1923. He noted his first name as "Birney" on his WWI Draft Registration.

Jean worked as a Telephone Operator for Dr. Moulton's Hartland & St Albans Telephone Company for 40 years retiring 7 years before her death. She was also a part-time correspondent for the Bangor Daily News for several years. She was a past Noble Grand of the Twilight Rebekah Lodge; a Charter Member of the Outlook Club; a past District Deputy of the Maine Federated Women's Club; a member of the Grace Linn Memorial Methodist Church, and of the WSCS of the church.

Jean's mother, Margaret (Brown) Smith, operated a millinery & dry goods business for several years on Commercial Street until 1910. She also sold the famous Sebasticook Walking Skirt at her store made by the Fuller-Osborne Manufacturing Company. Margaret is a sister of Myra Brown who married Charles Moor. (See Moor/Moore Family)

He registered for the Draft there in 1941 noting his Mother's name, his birth date & birth place. After the war he moved to Camden, Maine and operated the movie theater there. He ended his career managing several movie theaters back in Washington, D.C.

On November 22, 2008 the Maine State Museum in Augusta opened their "At Home in Maine" Exhibit. Among the various displays are "Birney's Bedroom" which includes toys, photos and personal items from the 1950s and 1960s donated by Birney & Dixie from their former Pleasant Street home. The bedroom is presented as it would have looked on Birney's graduation evening from Hartland Academy in 1966 and depicts the theme of growing up and leaving home. Three generations of the Moore Family lived in the house from 1923 through 2002.

# Bedroom of Birney Moore

You are now standing in the closet of Birney Moore's bedroom, viewing his room as it appeared on the day of his high school graduation from Hartland Academy. Birney was a typical Maine teenage boy. He played baseball, worked hard in school, and was popular among his friends. His bedroom was a place where he could pursue his hobbies and find some privacy.

Remembering his home. Birney later said, "I was anxious to leave for the big world, but I never thought I wouldn't be back." After college, he came back only for visits. But Birney's parents continued to keep his bedroom almost the same as he had left it after high school. The death of William H. Moore, a veteran of the Civil war, who served with Co. H. 1st Maine Cavalry, occurred Wednesday at the home of his son, Birney J. Moore, in Hartland. where he has been tenderly cared for during his illness which has covered a period of several weeks. The daceased who was 85 years of age on Nov. 5, was a native of St Albans, For many years he resided at Camp Benson, Newport, where he was engaged in farming, and where he was very highly respected by a large acquaintance of friends. He is survived by a widow, two daughters, Miss May P. Moore of Hartland, Miss Achsa V. Moore of Boston, Robie E. Moore of Dunmore, Pa., and Birney J. Moore of Hartland. All are at present in Hartland, called by the illness and death of their father. The funeral service will be held at the Birney Moore home in Hartland Saturday at 11 A. M. Rev. S. J. Willis will officiate. William's Death Date & Burial Location were confused on his transcribed online Service Record with another William H. Moore (1841-1908) from Cambridge who also served in the same Regiment & Company.
