Lancey Family

As with many traditional family stories passed along and retold by subsequent generations, there are slightly varying versions of the events which unfolded in the early years of Samuel's life. Exactly how much of any of the information from these early accounts is factual or endearing legend is left to the reader's discretion.

Samuel DeLancey/Lancey

Elizabeth is a granddaughter of Robert Pierce who in 1724 was a member of the Chelmsford "Snowshoe Company" under the command of Captain Robert Richardson in Lovewell's Indian Expedition. The Elizabeth Pierce Lancey D.A.R. Pittsfield Chapter organized November 2, 1916 was named in her honor.

Family tradition holds he was born Samuel DeLancey in Normandy, France and came with Major General Marquis de Lafayette of France in 1777 to join the American Colonists in the Revolutionary War. Various references to his birth place, original surname, his association with Lafayette and his military service are noted in several Lancey Family Reunion newspaper articles throughout the 1900s.

Records imply he dropped the traditional European styling prefix "De" and began using just Lancey as his surname when he formally enlisted with the colonists for the war in 1778 in his newly adopted home of Chelmsford, Massachusetts. A newer gravestone erected many years after his death include the inscription, "Samuel Lancey - Aug. 10, 1760 to Oct. 25, 1837 - Born Normandy, France - Enlisted Chelmsford, Massachusetts (for) Revolutionary War".

One of the accounts passed along by his many descendants was provided in an interview with his Great Granddaughter Florence (Moor) Smith which was interpreted and written by reporter Henry Buxton for a December 8, 1937 Bangor Daily News article as follows;

"Samuel DeLancey, a member of French Nobility, came over to this country with Lafayette to aid the cause of the colonists in the War for Independence. DeLancey, who was a familiar in the Court of (King) Louis XVI, was well versed in the social amenities of his period and used his gem studded snuff box with a grace that excited the awe and admiration of the early settlers of Hartland. Born in Caen, Normandy, France of noble lineage, he was a highly educated man and his value was quickly sensed by Dr. John Warren of Boston who engaged him as a surveyor and agent for his vast holdings in the Maine wilderness. DeLancey swamped out the first roads in Hartland, Palmyra and Corinna and surveyed large areas of heavily wooded land."

Revolutionary War service records for Samuel Lancey were provided by some of his descendants in the early 1900s for their respective membership applications to the Society of Sons or Daughters of The American Revolution and are transcribed verbatim below. Society applications at the time did not require a birth place nor did the original enlistment record which only included place of enlistment.

Lancy, Samuel; Chelmsford. Private, Capt. John Moore's Co., Col. Jonathan Reed's Regt. of guards; muster rolls dated Cambridge, May 9, and June 1, 1778; enlisted April 1, 1778; service guarding troops of convention; enlistment, 3 months from April 2, 1778.

Also, same Co. and Regt.; joined April 2, 1778; service to July 3, 1778, 3 mos. 2 days, at Cambridge; Also, Corporal, Capt. Thomas Hovey's Co., Col. Nathan Tyler's regt.; enlisted July 6, 1779; discharged Dec. 25, 1779; service, 5 mos. 25 days, at Rhode Island.

Also, same Co. and Regt.; pay roll for Dec., 1779, allowing 1 mo. 5 days service at Rhode Island, including travel (100 miles) home.

Lancey, Samuel; Chelmsford. List of 6 months men raised agreeable to resolve of June 5, 1780, returned as received of Maj. Joseph Hosmer, Superintendent for Middlesex Co., by Justin Ely, Commissioner, dated Springfield. Also, descriptive list of men raised to reinforce the Continental Army for the term of 6 months, agreeable to resolve of June 5, 1780, returned as received of Justin Ely, Commissioner, by Maj. Peter Harwood, of 6th Mass. Regt., at Springfield, July 2, 1780. age; 20 yrs., stature; 5 ft. 9 in., complexion; light, engaged for town of Chelmsford; marched to camp July 2, 1780, under command of Capt. Phineas Parker.

Also, list of men raised for the 6 months service and returned by Brig. Gen. Paterson as having passed muster in a return dated Camp Totoway, Oct. 25, 1780.

Also, pay roll for 6 months men raised by the town of Chelmsford for service in the Continental Army at North river during 1780; marched from home June 30, 1780; discharged Dec. 19, 1780; service, 6 mos., including 10 days (200 miles) travel home.

Massachusetts Vital Records note the names and birth dates for the six oldest children of Samuel & Elizabeth Lancey in Chelmsford, Massachusetts while their four youngest children were noted born in Westford, Massachusetts. The territory comprising the West Precinct of the town of Chelmsford was set off on September 23, 1729 and constituted a distinct and separate township by the name of Westford.

In the 1st U. S. Federal Census taken in 1790, the household of Samuel Lancey was listed in Chelmsford, Massachusetts. This Census only enumerated family household members without names in 2 age categories for males and 1 category for females of any age. The household noted 2 males under 16 (presumed sons William & Samuel), 1 male over 16 (presumed Samuel) and 2 females (presumed wife Elizabeth & daughter Mary).

In the 1800 Census, the household of Samuel Lancey was listed in Westford, Massachusetts noting 3 males under 10 (presumed sons Thomas, George & John), 2 males 10 thru 15 (presumed sons William & Samuel), 1 male 26 thru 44 (presumed Samuel), 1 female under 10 (presumed daughter Rebeccah), 1 female 10 thru 15 (presumed daughter Mary) and 1 female 26 thru 44 (presumed wife Elizabeth).

Soon after this, records indicate Samuel moved his family to the future town of Corinna where he had been hired as a surveyor by Dr. John Warren and oversaw the building of the first connecting main roads between the 4 neighboring townships Dr. Warren had purchased which became Corinna, Palmyra, St Albans and Hartland. Samuel later assisted local citizens to officially incorporate as the Town of Corinna in 1816 and called for their first Town Meeting by Warrant and served as Moderator.

"In 1804, Dr. John Warren of Boston purchased Township Number 4 in the Fourth Range of Townships North of the Waldo Patent in the County of Somerset, District of Maine; now known as Corinna. Soon after, Dr. Warren sent Samuel Lancey, Esq. to bush out a road near the center of the township east and west, giving him in exchange for his labor 170 acres of land, providing he should erect a house and barn thereon. Lancey fulfilled his contract and built his log cabin home at Corinna Center on land afterwards owned by Jacob Philbrick and Winkworth Allen. This barn was afterwards used for religious meetings until the erection of a school house." - A Brief History of Corinna, Maine 1804-1916

Lancey sold his Corinna homestead soon after it was built and moved his family to what was to become Palmyra where he built a house in the village area said to have been a replication of their former home in Massachusetts. In 1807, he served at Palmyra's 1st Town Meeting as Moderator and was elected Town Clerk.

Based on their ages, it <u>appears</u> most of Samuel & Elizabeth's 10 children came to Maine with them in the early 1800s and were living with them in 1810 except their oldest daughter Mary who had married and was living in New Hampshire. Their oldest son William had married in 1808 so it is possible but unproven he and his wife Susannah were living in his father's household. Samuel was the only Lancey noted as a Head of Household in the 1810 Census for Palmyra. His sons William, Samuel & George Lancey each appear as separate Head of Households in the 1820 Census for Palmyra as does Samuel.

Samuel later operated a stage coach stop and tavern from their home which was on the Norridgewock to Bangor Stage Coach Route. This same route also ran through West Hartland with a regular stop at James Fuller's similar establishment located at Fullers Corner. As noted below, James eventually married 2 of Samuel's daughters and the Lancey name is often used throughout the Fuller lineage.

Samuel was a Justice of the Peace in 1819, the Palmyra Delegate to the 1819 Maine Constitutional Convention and Post Master of Palmyra in 1828. He & Elizabeth remained in Palmyra the rest of their lives and were listed there in the Census Reports of 1820 & 1830.

Massachusetts Vital Records note his birth date in Chelmsford as William Lancey, one of six listed children of Samuel Lancey & Elizabeth Lancey. It is unknown whether he came to Maine with his parents in the early 1800s or joined them in Palmyra after his marriage. He & Susannah may have been living with his parents as seen above in the 1810 Census for Palmyra but no records have been found to confirm. He did not appear listed as a separate Head of Household until the 1820 Census in Palmyra. Following William's untimely death, Susannah never remarried and remained in Pittsfield where she raised their surviving children and managed the hotel William built with help from some of her children.

"In 1824, Col. William Lancey removed to Pittsfield from Palmyra and soon opened a store at his residence. In May of 1828 he was licensed to retail spirits for four months, and the following September he was licensed to be an inn holder at his dwelling house at the corner of Easy Street and Main Street,

known as the 'Lancey Hotel'. In 1839, William K. Lancey, son of William Lancey, began trading at the age of eighteen. The Inn was managed in succession by William Lancey then (his widow) Susannah Lancey, and finally by his eldest son, Isaac H. Lancey. In 1868, Isaac H. Lancey built, at a cost of \$15,000, the famous 'Lancey House' at the corner of Hunnewell Avenue and Main Street. The Lancey Hotel became the residence of the Lancey Family." - Pittsfield Historical Society

As noted in her obituary, she was born in Palmyra as one of their ten children. She left Pittsfield about 1831 at 12yrs old to work in Massachusetts where she eventually married John. They resided in Carlisle and had 2 children born to them, both of whom predeceased her. Following John's death, she remarried to Prescott and remained in Carlisle until his death when she returned to Pittsfield around 1885. She requested to be interred with her 2 husbands.

Likely named for his paternal Uncle Isaac Hurd Lancey. He built the famous Lancey House in 1868 which he operated at the corner of Hunnewell Avenue and Main Street in Pittsfield. They resided at the Lancey Hotel which his father built. He was attending his mother-in-law's funeral in Winslow when he suffered a fatal stroke.

In late 1865, Henry & Lydia, with their 2 young daughters, moved from Portland to Petrolia, Lambton County, Ontario, Canada having been attracted by the growing oil boom in the Lambton County area. He utilized the money he had made from the sale of his hardware business in Maine and invested heavily in land and oil production. He would quickly become one of the area's largest oil producers. Even with his success and great fortunes amassed in Petrolia as an oil producer, Henry returned to his native home in Pittsfield often for Lancey Family Reunions. He also paid homage to his hometown when he donated the large bell for Founder's Hall at Maine Central Institute in 1877 having it inscribed with the words, "KNOWLEDGE IS BETTER THAN GOLD". "The Mary Ann Lancey-Manson Park was donated to the town by John William Manson, a prestigious Pittsfield lawyer and businessman and named for his mother, a member of the prominent family who ran the distinguished Lancey House Hotel. The park was donated in two sections, the first and largest portion in 1926 during Mr. Manson's lifetime, including the access way extending from the end of Crosby Street, and the second upon his death in 1941 as a bequest in his Will." - Pittsfield Historical Society

He likely came to Maine with his parents in the early 1800s and appears to have been living with his parents in the 1810 Census for Palmyra as noted above.

It is unclear how Samuel may have ended up in Boston at the time of his presumed marriage. There is a record of a "Samuel F. Lancey" serving with the 1st Regiment of the Massachusetts Militia in the War of 1812 which could suggest but not prove he <u>may</u> have traveled there to serve. No other details were provided on the record but he would have been around 26yrs old at the time. No other record of a war pension or any widow's pension has been found.

The Register of Boston Marriages recorded the marriage of Samuel F. Lancey and Eliza McDonnell however no other details such as their age, birthplace or parents are noted. Records of their presumed children's births and baptisms <u>imply</u> they lived in Boston after they married as late as 1819.

Her Will filed on July 22, 1884 names several of her Jones step-siblings and their children as well as her sister Cecelia Lancey of Boston and her brother Samuel F. Lancey of Shenandoah, Iowa. She was noted born in Maine on her death certificate as the daughter of Elizabeth and Samuel F. Lancey. Her Will also included her request to be buried at Forest Hills Cemetery.

His recorded birth date is noted in a transcription summary of Roman Catholic Archdiocese of Boston Records but his baptism date was recorded as January 6, 1826 as the son of Samuel Lancey & Mary Stevens? No further confirmed records have been found.

While records of their children imply they lived in Boston until 1819, for reasons unknown they appear to have moved to Palmyra by 1820 as noted below. No other Samuel Lancey in his age range is known to have lived in Palmyra at the time and his father's household was noted separately as Samuel Lancey, Esq. There is no known listing for he and his family recorded in the 1820 Census in Boston.

The 1820 Census for Palmyra notes the household of Samuel Lancey enumerated with 1 male under 10, 1 male 10 to 16, 1 male 26 to 45 (presumed Samuel at 34yrs old), 3 females under 10 and 1 female 26 to 45 (presumed his wife Elizabeth at 31yrs).

Birth & death date records for his wife and their children indicate Samuel moved his family back to Boston soon after 1820 and they were not listed in the 1830 Census in Palmyra.

Elizabeth "Eliza" (McDonnell) Lancey's death on November 12, 1823 at 34yrs of Consumption (TB) in Boston was recorded in Massachusetts Vital Records of Boston Deaths & Interments noting her as "Elizabeth Lancey, family Samuel F. Lancey" along with 3 of their children as noted above.

His Will detailed many of the specific relationships to those he was leaving his estate as noted above. In 1875, G. M. moved to Auburn when he was about 14yrs old to briefly work as a clerk for his then widowed Uncle William Stockbridge Young and his brother Albert Young who had taken over the family run business at the Elm House Inn by 1870. William had married Percis Blake in 1865; she the youngest of G. M.'s mother's siblings.

The following year, he attended the Eaton Family School in Middleboro, Massachusetts before eventually taking a job in Portland at Lord, Haskell & Company which manufactured boots, shoes & moccasins and was co-owned by another family member Merrill Eliphalet Haskell. Merrill is a son of Peleg C. Haskell & Lois Fogg and both a cousin of his mother and a brother-in-law to his father after marrying George's youngest sister, Elizabeth Lancey (See below).

Around 1883, G. M. returned to Hartland where he took a job in the office of the Linn Woolen Mill and soon after married Annie in 1885. Following his father's death, he took over the family store business on Commercial Street and began operating as G. M. Lancey Dry Goods & Groceries and moved into the upstairs apartment with Annie.

G. M. became a successful merchant and insurance agent and was very active in many town affairs and local civic organizations. He served on the committee to sell the former Linn Woolen Mill location, the Hartland Public Library Board and the Hartland School Committee among numerous other endeavors. He would often make boat trips to The Commodore Club & Castle Harmony on Great Moose Lake to bring Wild Goose Club members and guests supplies.

In September of 1920, he sold his Commercial Street store block to Perley & Bertie Hanson who eventually operated it as B. W. Hanson Clothing Store. Following the sale, George & Annie moved into his late Uncle Calvin Blake's house on Academy Street where he continued selling insurance until his retirement. He had just retired when he passed away in 1942. (See Hanson Family)

Henry Warren Lancey I

Henry Warren Lancey was born April 5, 1826 in Pittsfield, Maine; 7th of the 9 children of William Lancey & Susannah Wheat. Henry lived in Pittsfield until he was 31 years of age when he married Miss Lydia Emmeline Drummond of Bangor, Maine on June 18, 1857 and the couple moved to Portland, Maine. Henry & Lydia had two daughters while living in Portland; Ella Warren Lancey, born August 9, 1858 and Emma Parker Lancey, born March 20, 1861. They also had a son, but he died very young.

Lancey started a wholesale hardware business in Portland that quickly proved quite successful for him, but as rumors of growing opportunities in the Canadian oil industry worked their way south across the border, Henry decided to sell his hardware business and set off for Canada.

In late 1865, Henry & Lydia, with their 2 young daughters, moved from Portland to Petrolia, Lambton County, Ontario, Canada having been attracted by the growing oil boom in the Lambton County area. He utilized the money he had made from the sale of his hardware business in Maine and invested heavily in land and oil production. He would quickly become one of the area's largest oil producers.

In the late 1860s, Lancey made one of the best decisions of his business career when he reinvested a portion of his money as a shareholder in an English oil syndicate called the Western of Canada. The investment proved substantially prosperous as 12 years later, Henry sold his holdings at a massive profit receiving \$250,000 for his shares; approximately \$5.8 million in today's money. Yet instead of running off and building a massive palace or starting his own town, Henry Lancey put his money back into Petrolia. For instance, he helped fund the Consumers Oil Refining Company, which was one of the town's first oil refineries. Henry would remain president of the refinery until just before his death. He was also the Chairman of the Mutual Oil Association, which was one of several Petrolia based oil cartels.

In July of 1871, Lancey purchased the assets of the Cresent Petroleum Association, a local oil producer which was having financial troubles. The company's assets included 190 acres of land southwest of Bear Creek, several small homes, steam engines, oil rigs, piping, and scores of other petroleum equipment.

Lancey decided to use some of the 190 acres of acquired land to create a high-class housing subdivision in the style of his New England birthplace. This development was up high on the hill overlooking Bear Creek, safe from the raging spring flood waters and in the quieter western side of Petrolia. He called his development "Cresent Park" after the company he had bought the land from.

By 1874, there were 13 homes built in Cresent Park. Henry named the first three streets that entered the new subdivision as Lancey Street, Warren Street & Henry Street. The other three streets he named Emmeline Street, Ella Street & Emma Street after his wife and two daughters. The open field in the center of the park had originally been designed for additional housing, but it was never built upon so it remained as an open area where residents could play croquet or have picnics.

Lancey built a beautiful timber frame house in Cresent Park with colonial styling to match the atmosphere of his subdivision. The home is now owned by Martin and Dorothy Dillon who have gone to great extent to retain the originality of the home utilizing period lighting and garden architecture.

Even with his success and great fortunes amassed in Petrolia, Henry returned to his native home in Pittsfield often for Lancey Family Reunions. He also paid homage to his hometown when he donated the large bell for Founder's Hall at Maine Central Institute in 1877 having it inscribed with the words, "KNOWLEDGE IS BETTER THAN GOLD". (See bell photo below)

As an Anglican, Mr. Lancey was an honorable, honest and upright man who demanded equal honesty and justice from others. In February of 1880, he was openly criticized in a local Petrolia newspaper called 'The Topic'. Henry felt himself so insulted by the remarks made in the Liberalist newspaper that he sued the company for \$3,000 for libeling his character and demanded the name of the author. The charge was eventually dropped by Lancey and he showed no hard feelings when The Topic later rented space in the Lancey's store block.

In 1881, Lancey decided to build a massive brick store block in Petrolia's west end. Until this point the majority of development in Petrolia was taking part in the eastern side of Bear Creek. Many skeptics laughed at Mr. Lancey, claiming him to be a fool for wanting to build such a nice and expensive structure so far from the business district in the east end. One man claimed that Lancey's plan "would be pure folly" since there would be no one to buy from him in the west end. Lancey brushed aside the criticism and mockery and built his block anyway.

In a show of wit, Henry named his store block "Lancey's Folly" carving the name into a keystone on the front for all to see. The store was located on the corner of Tank Street and Petrolia Street (now Petrolia Line) where Crabby Joe's restaurant is located today. His new store block started such a building boom on the western side of Bear Creek that within a few short years the focal point of the town had migrated from the eastern side to the west. Lancey's mockers could do nothing but watch as other large brick buildings went up along Petrolia Street such as Van Tuyl & Fairbank's massive store and the Kerr building. The Lancey's Folly block housed a general mercantile store operated by Henry as well as the Scarsbrook General Store. Later a creamery owned by his future son-in-law William English would operate on the main floor while the local Masonic Lodge met on the second floor.

Henry showed very little interest in the political affairs of Petrolia. He did serve one term on Council, but never took part ever again. He left no record of any political affiliation despite his popularity and prominence in the town. Lancey instead was more interested in the business affairs of the town, helping to promote economic growth wherever possible.

Henry Warren Lancey passed away on August 15, 1891 in Petrolia at 65 years old with his death certificate stating the cause of his death as Paralysis. All stores in the town of Petrolia closed from 1pm to 4pm for Mr. Lancey's funeral. His wife Lydia died a few years later on November 5, 1899 at 67 years old of an Organic Disease of the Bowel. She had showed no signs of being gravely ill until the third day when in the morning the disease entered an acute phase and she died that day. Records indicate they were both interred at Hillsdale Cemetery in Petrolia.

Henry & Lydia's oldest daughter Ella Warren Lancey married William English on April 13, 1892 in Petrolia. William was a local book keeper and manager who had begun working for Henry Lancey as a clerk when he was 16 years old. Born March 4, 1860 in London, Ontario, William English became instrumental in the Lancey Empire and also made quite a name for himself in Petrolia.

In 1881, William worked as a live-in book keeper for the Burgess family in Petrolia and later became the manager for the Crown Savings & Loans Company. He was also hired to manage the Petrolia Wagon Works, a local company plagued with financial trouble. He also started Lambton-Kent Creameries, a local company that shipped butter to Great Britain. When the Petrolia Water Works was built, William became Petrolia's first Water Commissioner. This led to his role in municipal government where he later served as both a member of council and Mayor. In politics he was a Conservative with Liberal views. William passed away on August 14, 1936 in Petrolia and Ella passed away on March 5, 1942 in Petrolia. They are interred together at Hillsdale Cemetery in Petrolia.

Henry & Lydia's youngest daughter Emma Parker Lancey married Henry Bond Sherman on June 13, 1883 in Petrolia. They moved to Chicago where he was in the tea, coffee & spice business for several years before illness forced him to retire in 1896. They moved to Pasadena, California that same year where Emma passed away on January 12, 1901. She was interred at Mountain View Cemetery in Altadena, California joined there by Henry upon his death in 1925.

The Lancey Family made great contributions in the business and commercial planning of the town of Petrolia. While the "Lancey's Folly" building was torn down in the 1960s, the other brick buildings that were built because of Henry Lancey's business sense and risk taking now form Petrolia's Victorian Downtown. His subdivision Cresent Park remains intact and well preserved. The original street names and homes are still present and well-kept by their 21st century owners.
